General Information

The LAAR Bylaws state the following criteria for all candidates to be qualified for positions on the Board of Directors.

- Must have been a REALTOR® member of LAAR for a minimum of three (3) years.
- Must have served on two (2) LAAR committees, one of which must have been within the preceding four (4) years.
- Must be committed to attending all scheduled Board of Directors meetings and association events: especially events that are attended by State or National leaders.
- Must be available during regular business hours (9-5) for meetings.
- Must be fiscally responsible and understand the association is operated as a business.
- Must understand the importance of advocacy and RPAC. Invest in RPAC.
- Must represent the association at civic and community functions.
- Must have completed C2EX or have it completed by 12/31/2025.

For additional information on LAAR Officers and Directors elections, see LAAR bylaws, Article IX.

<u>Vice President-</u> The Vice President will automatically move to the position of President in 2027. The VP must agree to travel to TN REALTORS® conferences (2-3 each year) and NAR conferences (3 each year) in 2026 and 2027.

<u>Director-</u> Attendance of meetings of the Board of Directors (1st Wednesday of each month) and general membership meetings (Spring and Fall) are required. Absence from two (2) meetings without an excuse deemed valid by the Board of Directors shall be considered a resignation in accordance with LAAR bylaws.
